JOB DESCRIPTION:

- Develop and deliver a site-based program of guided physical fitness and gaming activities
- Work with the site coordinator to address healthy lifestyle experiences (tobacco, drug, alcohol, truancy and violence prevention)
- Maintain and submit student records for attendance
- Submit beginning of the year, middle of the year, and end of the year physical fitness assessment data
- Attend staff meetings and trainings as required
- Assist with programs planned for family members of students and community members
- Invite appropriate community members to present topics relative to the position
- Supervise afterschool students
- Arrive and depart at designated times
- Maintain student confidentiality
- Use planning time effectively
